### Title: **Compliance Calendars**

## Overview

The President customarily delegates to a senior institutional official ("responsible official"), typically a Vice President, responsibility for the oversight of specific compliance programs, activities, conduct or endeavors.

To assist responsible officials, the Office of Compliance Services has generated foundational unit-specific compliance calendars identifying the University's regulatory reporting obligations primarily to federal agencies.

## Applicability of the Procedure

This UOP applies to responsible officials and those involved in regulatory reporting.

### **Definitions**

<u>Compliance Calendar:</u> A comprehensive list of University reporting requirements, primarily federal, organized by organizational unit and identifying the legal requirements, oversight agencies, reporting timing and frequency, University assigned responsibility and existing processes.

### **Procedures**

Responsible officials are responsible for maintaining the accuracy and completeness of the compliance calendar(s) for their areas of responsibility and for updating the Office of Compliance Services whenever a change is identified and implemented on the calendar. Therefore, at least annually, responsible officials, in consultation with the Office of Compliance Services and the Office of General Counsel as appropriate, must review their compliance calendar(s) for accuracy and completeness.

The Office of Compliance Services will maintain official University records related to the initial development of the calendars, and the annual calendar review process, including any subsequent additions and revisions.
